1 Fire Station nomination for National Register status

Mark Dollase stated that he hopes that the Historic Landmarks Foundation can help us with the expenses of hiring a professional consultant/historian to complete the nomination paperwork and guide our project through the system. He emphasized that we need to get an application to them by December 31, 2009 (if possible) to be considered for a grant from HLF. They will meet on January 11 to consider all applications. The maximum amount of a grant would be \$10,000 or 50% of our consultant budget, whichever is smaller.

The committee received five proposals from consultants and professional historians:

All are well-qualified to handle this project. The committee reviewed and discussed each proposal and selected Connie Zeigler to do the work for us. Chris will contact Elizabeth Marshall who will notify Connie by phone of her selection. Sharon will prepare an official acceptance letter for Elizabeth's signature. After that has been accomplished, we will send letters to the other four.

Connie's fee would be \$3050; HLF's 50% grant would be \$1525. The committee factored in approximately \$575 for a marker and perhaps a directional sign, bringing to \$2100 the total needed to be raised by the committee.

Michelle and Kevin had a sample counter-top canister to place near the cash registers in Broad Ripple area businesses to collect spare change and bills for the project. They will continue to develop a distribution and collection plan.

Chris presented a very preliminary draft of a fund raising letter to go to various individuals and businesses in the Broad Ripple area requesting donations to this project. Several suggestions were put forth by the committee, and Chris will revise and distribute to those present for final edits. She will prepare one version for USPS distribution and another for the email list.

Sue Zilisch promised to get the names and addresses of the owners of the 46 homes which have been included in the BR Historic Home Tour over the years. Sue had previously offered to contact Gregg Harris, Chief of the BRipple Fire Station regarding approaching the firefighters themselves for support of this project but did not get a chance to report on this at the meeting (friendly reminder, Sue ①).

We can use the Broad Ripple Alliance for Progress to receive the donations since they are the 501(c) (3) foundation of the BRVA. BRVA already uses PayPal, and we could utilize this safe method for those who wish to donate online.
