2. Fire Station

- **Nomination for National Register**—Nothing new to report on the nomination. Connie Zeigler is working on an application for the Watson Park Neighborhood to be considered an historic area.

It was suggested that we invite descendents of the Coil family to the Firehouse dedication and to the 175th celebration. Sue Zilisch has information on family members who are doing research into their family's Broad Ripple roots.

4. <u>Historic Photos of the Village</u>

Jay Williams has historic train photos and some of them probably pertain to Broad Ripple. Alan Hague will contact him.

Chris contacted Gary Yohler regarding his massive collection of old photos from *The Indianapolis Times*. Gary said that he has about 170,000 images, mostly prints. They are just in boxes and file cabinets, mostly filed under how the accompanying article appeared in the paper – "flood," "dam," etc. The majority are in good condition. Chris sent him the committee's research list and he said he'd see if he could find corresponding photos which he said he would be happy to scan onto a disk for us. We would credit him with any of his photos which we might use.

Gary had several other items of interest to share:

- He used to own the old Apple Press building which is just south of Brugge. He said it may be one of the oldest buildings in Broad Ripple. Parts of the interior may still be intact... almost original. He said the building should be saved, that there is a lot of history behind this house, that it was possibly built by Jacob Coil. He suggested that we add this building to our list. Gary said that the brother of the guy he bought it from years ago may still be alive. Bill Noel owns the building now.
- Gary also said that he may come to a winter meeting of our committee.
- Suggested we contact Paul Meister who might also have some old photos he might share
